**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is The PTV Motor Company. Its principal office address and business mailing address is 925 Arthur Godfrey Road, Suite 104b, Miami Beach, Florida 33140.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock, having a par value of \$.01 per share.

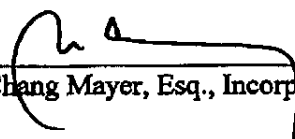
