ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
DAIHAN SCIENTIFIC NA, INC.

The undersigned corporation, in accordance with the Florida Business Corporation Act and its Bylaws, hereby adopts the following Articles of Amendment:

1. The name of the corporation is Daihan Scientific NA, Inc.
2. The Articles of Incorporation were filed with the Florida Department of State on October 30, 2014, and the Florida document number assigned to this Company is P14000088941.
3. Article I of the corporation's Articles of Incorporation is hereby deleted in its entirety and the following is substituted therefor:
