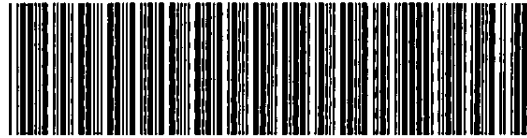

THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) for the Purpose of forming a corporation under the laws of the State Florida adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is C & B AC SERVICES, INC,

ARTICLE II - DURATION

The period of its duration is perpetual.

EFFECTIVE DATE: JANUARY 01, 2015

ARTICLE III - PURPOSE (S)

The purpose(s) for which the corporation is organized are "To operate An Air Conditioning (AC) and Appliance Service Business, consistent with any other sales, installation, maintenance And service activities in the industry". "And any other lawful business Activity for which corporation may be incorporated under Chapter 607 of the Florida Statutes".

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares, which the corporation shall have authority to Issue, is One Million, 1,000,000 shares of common stock having a par value of One Dollar (\$1.00) each.

Section 1 - Stated Capital: The sum of all the outstanding shares of the corporation at any particular time shall be the capital of the corporation.
