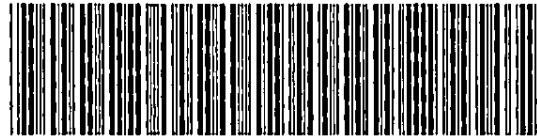

Resolved, That at a meeting of the Share Holders held on November 3rd, 2018, with all three (3) shareholders present, unanimously cast their vote to amend the following two Article of Incorporation.

ARTICLE 1 – NAME


Whereas the old name of the corporation is **C&B BLACKFLOW SERVICES, INC.** The amended new name shall be: **C & B BACKFLOW, AC AND MAINTENANCE SERVICES, INC.**

ARTICLE 111 PURPOSE(s)

Whereas the old Article 111 reads: The purpose(s) for which the corporation is organized are “To operation a Backflow Service Business, consistent any other sales, installation, certification, maintenance and service activities in the industry”; “And any other lawful business activity for which corporation may be incorporated under Chapter 607 of the Florida Statutes”.

The amended new purpose(s) under Article 111 shall read: The purpose for which the corporation is organized are “To operate a general Domestic, Industrial and Commercial Maintenance Services Business consistent with sales, repairs, installation of Backflow, a/c, home appliance and “Any other Lawful business activity for which corporation may be incorporated under Chapter 607 of the Florida Statutes”.

There being no further changes or amendment to the Article of incorporation; the Articles remains as previously submitted.
