RESOLVED That at a joint meeting of the Share Holders and Directors held on February 22nd, 2019 being all of all the shareholders and directors present. All three (3) share-holders and one (1) present, unanimously cast their vote to amend the following two Article of Incorporation.

ARTICLE 1 – NAME

Whereas the old name of the corporation is C&B BLACKFLOW, AC, AND MAINTENANCES SERVICES, INC. The amended new name shall be: C & B MAINTENANCE SERVICES, INC.


ARTICLE 111 PURPOSE(s)
