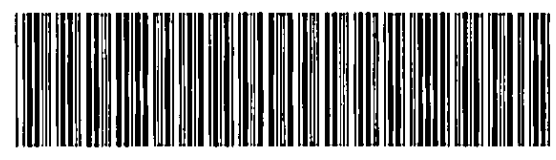


**ARTICLE II-Resolutions of the Shareholders**


