The undersigned, for the purpose of forming a for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

## ARTICLE I.

### NAME

The name of this corporation shall be **SEAN GREEN, INC.** (hereinafter called the "Corporation").

## ARTICLE II.

### PRINCIPAL OFFICE AND MAILING ADDRESS

## ARTICLE III.

### PURPOSE

The Corporation is an (S) for-profit corporation organized for the purpose of engaging in any lawful act, or activity for which for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida.
