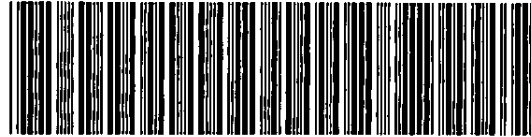

The name of this corporation is Jessica L. Corns Insurance Agency, Inc., located at 801 Maplewood Drive, Suite 9, Jupiter, Florida 33458-8800.

Article II. Duration

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

Article III. Purpose
