ARTICLES OF INCORPORATION

OF

THE SAILOR SEAFOOD & CHICKEN, CORP

The undersigned acting as subscriber(s) of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such Corporation.

Article I

The name of the Corporation is: **THE SAILOR SEAFOOD & CHICKEN, CORP**

Article II

The purpose for which the Corporation is organized is to engage in any activity business permitted under the Law of the United States and the State of Florida.


