

ARTICLES OF INCORPORATION OF SKD ENTERPRISES, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I – NAME & EFFECTIVE DATE

The name of the corporation shall be **SKD ENTERPRISES, INC.** and the effective date of incorporation shall be January 1, 2015.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 840-J Meadowland Drive, Naples, Florida 34108
