This Article of incorporation of J.W. Advisory Services, Inc. (the "Corporation") has been duly executed and is being filed in compliance with Chapter 607 F.S., as amended from time to time.

ARTICLE I Name

The name of the corporation is "J.W. Advisory Services, Inc."

ARTICLE II

The principal office and mailing address of the Corporation is 8320 SW 62nd Ave South Miami, FL, 33143.

ARTICLE III Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation is to transact all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as hereafter amended and supplemented, and any successor statute thereto, as thereafter amended and supplemented.

The general purposes specified in the foregoing clauses of this Article shall, unless expressly limited, not be limited or restricted by reference to, or inference from, any provisions in this or any other Article of these Articles of incorporation shall be regarded as independent purposes and shall be construed as powers as well as purposes.
