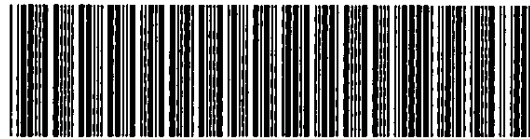

#### ARTICLE I

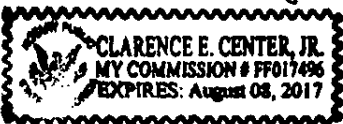
