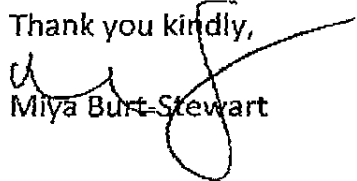
Hello Mr. Scott,
