**ARTICLES OF INCORPORATION**  
**OF**  
**EQUINE TAX GROUP FL, INC.**

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following *Articles of Incorporation* for such Corporation:

**ARTICLE I**

The name of the Corporation is: EQUINE TAX GROUP FL, INC.

**ARTICLE II**

This Corporation shall commence its existence immediately upon the filing of these *Articles of Incorporation* and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III**

The Corporation is organized to conduct any and all lawful business.

**ARTICLE IV**

The capital stock authorized the par value thereof and the characteristics of such stock shall be as follows:



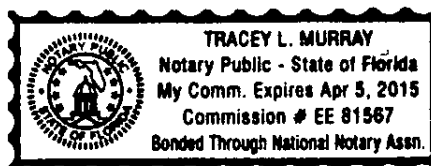
