## ARTICLES OF INCORPORATION FOR JENNIFER GANGAWER, P.A.

I, the undersigned hereby associated myself for the purpose of becoming a corporation under and by virtue of the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

#### ARTICLE I CORPORATE NAME

The name of this corporation shall be:

## ARTICLE II NATURE OF BUSINESS AND POWERS

The objects and purposes of this corporation and the general nature of the business or businesses to be transacted shall be as follows:

- 1. To primarily engage in the business of real estate sales and related services without limitation.
