

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FIERCE FIT, INC.

Pursuant to the provisions of section 607.0602 of the Florida Business Corporation Act

- 1. Pursuant to Section 607.0602 of the Florida Corporation Act (the "FBCA"), Fierce Fit, Inc. (the "Company") hereby adopts the following Amendment to its Articles of Incorporation (the "Amendment"):
- 2. The name of the Corporation is Fierce Fit, Inc.
