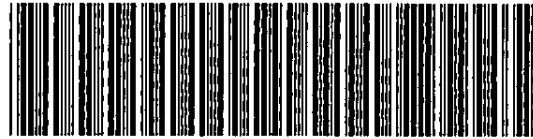

PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, CHRISTINA F ESPENSCHIED OF 1314 CARPENTER BRANCH COURT, OVIEDO, FLORIDA 32765 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT CHRISTINA F. ESPENSCHIED BY EXECUTION OF THESE ARTICLES DOES ACCEPT TO ACT IN THIS CAPACITY AND AGREE TO COMPLY WITH THE PROVISIONS OF SAID ACT RELATIVE TO KEEPING OPEN SAID OFFICE LOCATED AT THE ABOVE ADDRESS.

#### ARTICLE X
