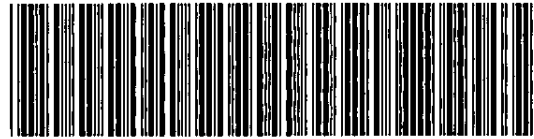

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida Professional Services Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I

Name

Voting Trusts

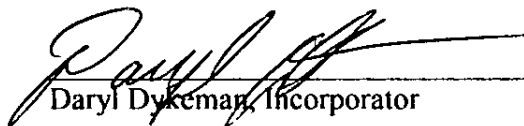

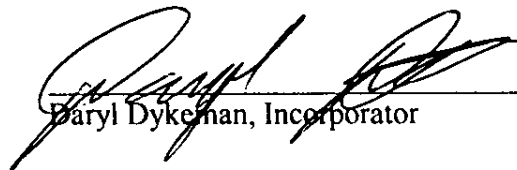
