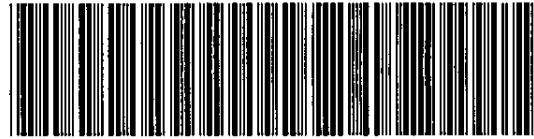

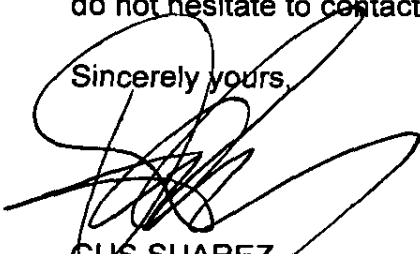

CHANGE OF REGISTERED AGENT:

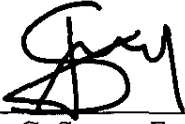
Enrique Bassas is *deleted* as Registered Agent of the Corporation.

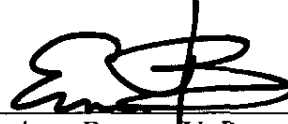

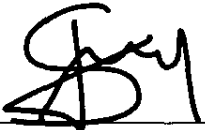
