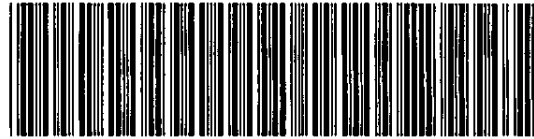

CHANGE OF DIRECTORS/OFFICERS:

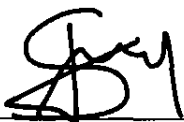
Enrique Bassas is hereby *deleted* as Vice President of the Corporation.
