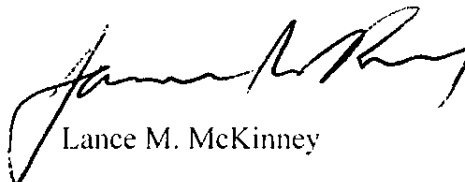

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares with a par value of \$1.00.

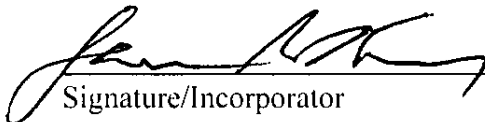
ARTICLE V. INITIAL REGISTERED AGENT AND ADDRESS
