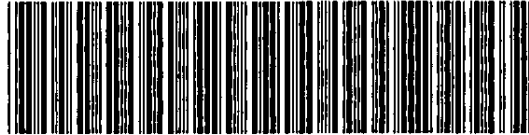

ARTICLE I. NAME

The name of this corporation is HEALTH RISKS CONSULTANTS, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2015, and shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

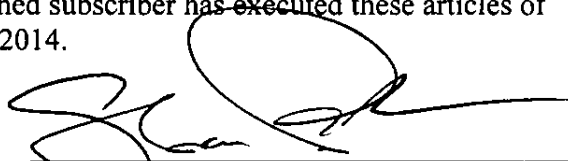

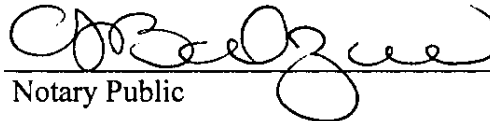

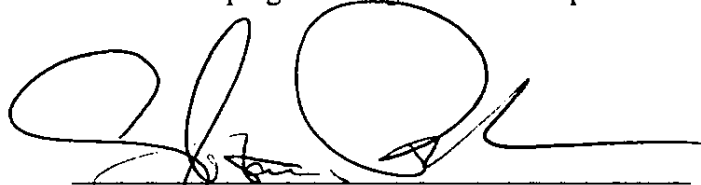
