Dear Sir/Madam:

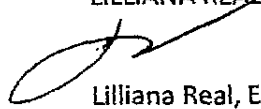
I am an attorney in Florida, in good standing, for 19 years. I opened a Florida corporation last week called \$99-MPH, INC. for mediations as I am a certified mediator and I will be charging \$99 per hour so the name was short for \$99 Mediations Per Hour. Shortly thereafter, I went to my bank to open a bank account and realized the IRS would not accept the "\$" as part of the name of the corporation. We obtained an EIN number for 99-MPH, INC. Since the process to change the corporate name was all by mail, I decided to open a new corporation to match the EIN number application in the name of 99-MPH, INC. which was flagged and not opened because it was too similar with \$99-MPH, INC.

I have now also dissolved \$99-MPH, INC. and I have no intention of reinstating \$99-MPH, INC. since I cannot obtain an EIN number with the "\$" character in the name.
