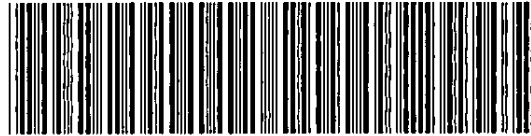

OF
CLOUD 9 LIVING INC.**

**ARTICLE 1
NAME**

The name of the corporation is Cloud 9 Living Inc. (the "Corporation").

**ARTICLE 2
PRINCIPAL OFFICE**

The street address of the initial principal office of the Corporation is 4999 Pearl East Circle, Suite 102, Boulder, Colorado 80301.

**ARTICLE 3
AUTHORIZED SHARES**

The Corporation shall have authority, to be exercised by the Board of Directors, to issue no more than ten thousand (10,000) shares of capital stock. These shares shall be one class, no par value, and shall be designated as "Common Stock." The holders of Common Stock shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution.

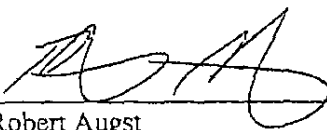
**ARTICLE 7
