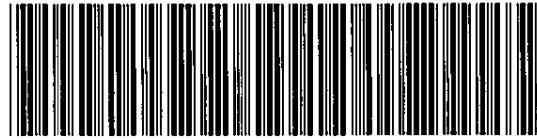


Please be advised that we wish to dissolve our current For Profit Corporation and reapply as a Not For Profit Corporation with the same name.


