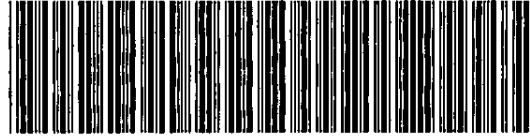

**ARTICLES OF INCORPORATION  
OF  
GEOFFREY JONSSON  
PROFESSIONAL ASSOCIATION**

Pursuant to the Florida Business Corporation Act (the "Act"), the undersigned hereby adopt the following Articles of Incorporation for purposes of incorporating Geoffrey Jonsson, P.A., a Florida for profit corporation (the "Corporation"):

**ARTICLE I  
NAME**

The name of the Corporation shall be Geoffrey Jonsson, P.A.

**ARTICLE II  
PRINCIPAL BUSINESS ADDRESS & MAILING ADDRESS**

**ARTICLE III  
BUSINESS PURPOSE**

A proposed amendment to these Articles of Incorporation shall become effective at such time as the majority shareholder of outstanding voting shares has approved it.


