ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Killik Inc. Its principal office address and mailing address is

The Corporation shall have a perpetual existence.

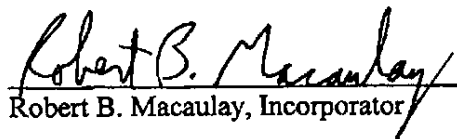

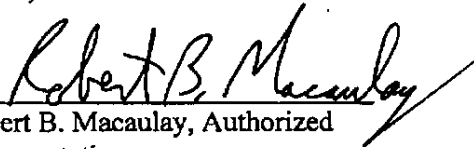
