ARTICLES OF INCORPORATION OF KILLIK INC.

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Killik Inc. Its principal office address and mailing address is 2020 North Bayshore Drive, Suite 1108, Miami, Florida 33137.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK
