## AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF ODYSSEY AMERICA REINSURANCE CORPORATION

FIRST: The name of the corporation shall be Odyssey Reinsurance Company (the "Corporation").

SECOND: The period of the Corporation's duration is perpetual.

THIRD: The Corporation was originally incorporated in the State of Nebraska on September 10, 1986.

FOURTH: The Corporation was originally incorporated under the name Commercial Risk Underwriters Insurance Company and subsequently changed its name to Transamerica Reinsurance Company on December 13, 1987, TIG Reinsurance Company on August 31, 1993 and then to Odyssey America Reinsurance Corporation on October 27, 1999.

FIFTH: The nature of the business to be transacted and purposes to be promoted and carried out by the Corporation are as follows:

- (a) To transact and write all of the type of insurance and reinsurance, with the exception of life insurance, title insurance and variable annuities, authorized by Title 38a of the Connecticut General Statutes; and
- (b) To engage in any lawful act or activity for which corporations may be formed under the Stock Corporation Act of the State of Connecticut.

SIXTH: The designation of each class of shares, the authorized number of shares of each such class, and the par value of each share thereof are as follows:

Common	33,500	\$300.00

SEVENETH: The minimum amount of stated capital with which the Corporation shall commence business is One Thousand Dollars (\$1,000.00).

EIGHTH: The Corporation shall indemnify and reimburse shareholders, directors, officers, employees and agents as required by Section 33-320a of the Stock Corporation Act of the State of Connecticut, including any amendment to or substitutions for such Section 33-320a which may be made from time to time.
