

ADDENDUM TO ARTICLES OF INCORPORATION FOR PACIFIC PREMIER CAPITAL, INC.

ARTICLE IV – Shares of Stock

Pacific Premier Capital, Inc. is authorized to have two classes of stock; the classes shall be designated as "Class A" and "Class B." Each class shall have the following characteristics:

There shall be authorized eight-billion-five-hundred-million (8,500,000,000) shares of Class A stock. Class A shares shall have unlimited voting rights, and shall have the right to receive the net assets of the corporation upon dissolution.

There shall be authorized one-billion-five-hundred-million (1,500,000,000) shares of Class B stock. Class B shares shall have no voting rights, and shall have no rights to receive any of the assets of the corporation upon dissolution.

ARTICLE VIII – Effective Date of Incorporation

Pacific Premier Capital, Inc. shall have an effective date of incorporation of January 1, 2015.
