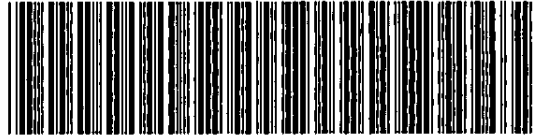

ARTICLE I
Name and Address

Amendment**

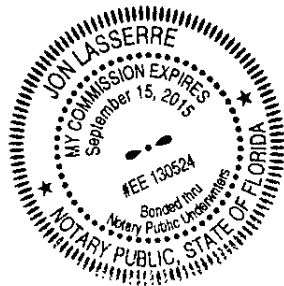

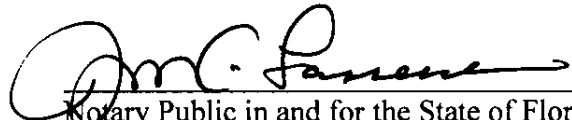

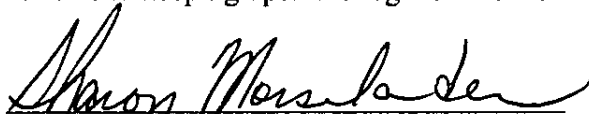
