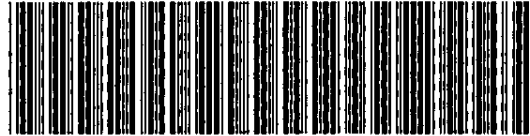

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.


ARTICLE IX


ARTICLE X
