ARTICLE I - NAME

The name of this corporation is BAY POINT MANAGEMENT ASSOCIATES, INC.

ARTICLE V - BOARD OF DIRECTORS

The corporation shall have up to three (3) directors. The number of directors may be either increased or diminished from time to time by a method of election as stated in the Bylaws, but shall never be less than one (1). The name and address of the director of this corporation is as follows:

ARTICLE VI - PREEMPTIVE RIGHTS

ARTICLE VII - CUMULATIVE VOTING RIGHTS

At each election for directors, every shareholder entitled to vote in the election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing the votes on the same principle among any number of the candidates.

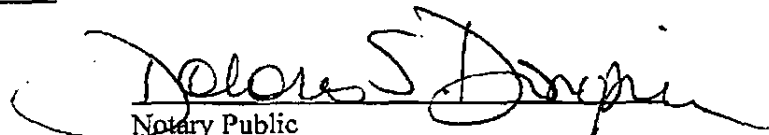

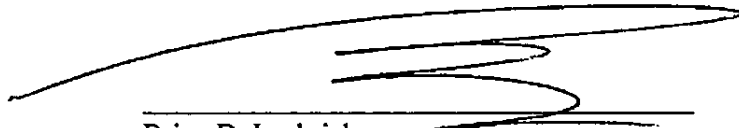
