ARTICLES OF INCORPORATION

OF

BREVARD PHYCHOLOGICAL ASSOCIATION, INC.

ARTICLE I - NAME

The name of the corporation is Brevard Phychological Association, Inc., at 1611 South Apollo Blvd., Melbourne, FL 32901 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
