

1. Introduction. Eddie J Lewis, III, being duly sworn, deposes and says:



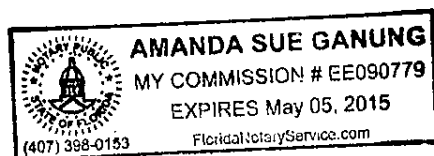
