**ARTICLES OF INCORPORATION
OF
GRACE HARBOR GROUP, INC.**

THE UNDERSIGNED, acting as the incorporator of Grace Harbor Group, Inc., a Florida corporation (the "Corporation"), under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE ONE:
NAME

The name of this corporation is Grace Harbor Group, Inc.

ARTICLE TWO:
PRINCIPAL OFFICE

The street address of the principal office and mailing address of the Corporation is 1325 Snell Isle Blvd. NE, Unit 306, St. Petersburg, FL 33704.

ARTICLE THREE:
REGISTERED OFFICE AND AGENT

The mailing address and street address of the registered office of the Corporation are One Independent Drive, Suite 1300, Jacksonville, Florida 32202. The name of the registered agent of the Corporation is F & L Corp.

ARTICLE FOUR:
DURATION

The term of existence of the Corporation shall be perpetual.

ARTICLE FIVE:
PURPOSE

The Corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE SIX:
CAPITAL STOCK

The Corporation shall have authority to issue the following shares of stock:

(a) Five Hundred Thousand (500,000) shares of voting common stock, with a par value of \$.001 per share, which shall be designated the "Class A Common Shares"; and

(b) Five Hundred Thousand (500,000) shares of non-voting common stock, with a par value of \$.001 per share, which shall be designated the "Class B Common Shares".

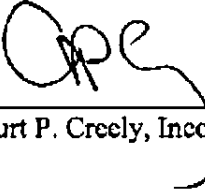

Each Class A Common Share and each Class B Common Share shall have identical rights with regard to dividends, liquidation distributions and all other preferences, limitations, and relative rights and characteristics; provided, however, that the holders of the Class A Common Shares shall be entitled to one vote per Class A Common Share and the holders of the Class B Common Shares shall have no voting rights relating to the Class B Common Shares. The term "Common Shares" shall be utilized to refer to all shares of authorized common stock, without distinction between Class A Common Shares and Class B Common Shares.

ARTICLE SEVEN:
INCORPORATOR
