INDEMNIFICATION

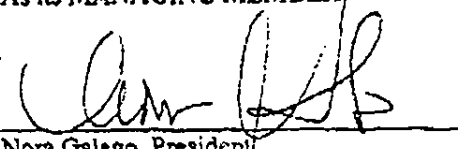
