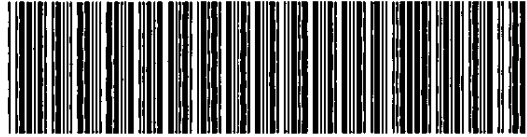

THE UNDERSIGNED subscriber, a natural person competent to contract, acting as incorporator of corporation (hereinafter referred to as the "Corporation") under the provisions of the statutes of the State of Florida, does hereby make, subscribe, acknowledge and file the following Articles of Incorporation:

ARTICLE 1

**Name:** The name of the Corporation is: **YEHUDA LEVY DESIGN CORP**

ARTICLE 2

**Purpose:** The Corporation may engage in any activity or business permitted under the laws of the United States and of Florida. It will mainly engage in the design of wedding dresses and other clothing articles

ARTICLE 3

**Number of Authorized Shares:** The aggregate number of shares of capital stock which the Corporation shall have authority to issue is One Hundred (100) Shares of Common Stock of a par value of \$1.00 per share.

**Payment for Shares:** The consideration for the issuance of shares of capital stock of the Corporation may be paid, in whole or in part, in money, in other property, tangible or intangible, or in labor or services actually performed for the Corporation. When the payment of the consideration for which such shares are to be issued shall have been received by the Corporation, such shares shall be deemed to be fully paid and not assessable. In the absence of fraud in the transaction, the judgment of the Board of Directors or the Stockholders as the case may be, as to the value of the consideration received for such shares shall be conclusive.

**Initial Capital:** The amount of capital with which the Corporation will begin business shall not be less than \$500.00

ARTICLE 5

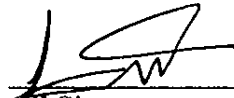

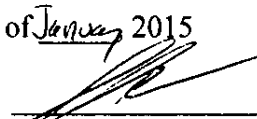
