

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 621 of the Florida Statutes, hereby form a Professional Services Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be **ADRIANNE N. HAUFF DC, P.A.**

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 30 day of January 2015, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be the conduct of chiropractic medicine and related sales and services and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV
CAPITAL STOCK


ARTICLE VII

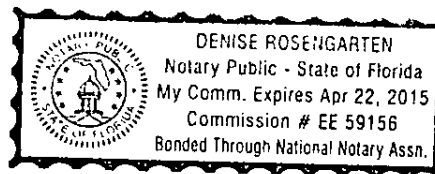
