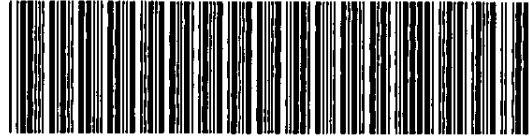

OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Tenderseas, Inc. and its address is 225 Arvida Parkway, Coral Gables, Florida 33156.
