ARTICLE I

The name of this corporation shall be:

ARTICLE II

This corporation may engage in the transaction of any or all-lawful business under the laws of the United States and the State of Florida.

The maximum number of shares of stock authorized to be issued by this corporation at any time is 300 shares of \$ 1.00 par value each.
