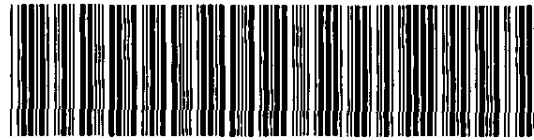

The corporation shall be authorized to create and issue 100 shares of Common Stock.


