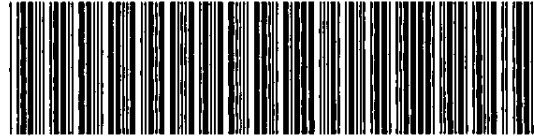


We are a small cleaning company and cannot afford the \$900.00 reinstatement fee.
