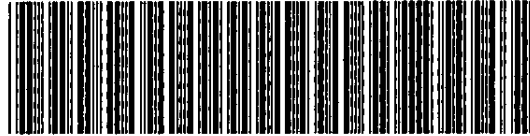

**ARTICLES I NAME**
