**ARTICLES OF INCORPORATION

The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is **LOCHABER WOLFE, INC.**, and its principal place of business and mailing address is 300 South Orange Avenue, Suite 1000 (JGH), Orlando, FL 32801.

ARTICLE II

COMMENCEMENT OF EXISTENCE

The existence of the Corporation commences on the execution by the incorporator unless the filing of these Articles of Incorporation occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing these Articles of Incorporation.

ARTICLE III

Purposes

The corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

Authorized Shares of Capital Stock

The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares of common stock having a par value of \$.01 per share. All or any part of said common stock may be paid for in cash, in property or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All common stock when issued shall be paid for and shall be non-assessable.

This corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


