ARTICLES OF INCORPORATION

OF

J & B LAND HOLDINGS, INC.

The undersigned, being a natural person of the age of twenty-one (21) years or more and a subscriber to the shares of the Corporation to be organized hereunder, for the purpose of forming a corporation under Florida Statutes Chapter 607, as amended, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation is J & B LAND HOLDINGS, INC. and the street and mailing address of the Corporation is 2860 Coco Lakes Drive, Naples, Florida 34105.

ARTICLE II

The street address of the initial registered office of the Corporation shall be 2860 Coco Lakes Drive, Naples, Florida 34105 and the name of the initial registered agent at that address shall be Bernard G. Hackman.

ARTICLE X

Each director or officer, or former director or officer of this Corporation and his legal representatives, shall be indemnified by the Corporation against liabilities, expenses, counsel fees, and costs reasonably incurred by him as a result of any action, suit, proceeding or claim in which he is made a part by reason of his being or having been such director or officer; and any person who at

the request of this Corporation, served as director or officer of another corporation in which this Corporation owned corporate stock, and his legal representative, shall in like manner be indemnified by this Corporation; provided, that in neither case shall the Corporation indemnify such director or officer with respect to any matters in which he shall be finally adjudged in any such action, suit, or proceeding to have been liable for negligence or misconduct in the performance of his duties as such director or officer.
