**ARTICLES OF INCORPORATION
OF
FLORIDA NATION TOURS, INC.**

ARTICLE I

The name of the corporation is Florida Nation Tours, Inc. (the "Corporation").

ARTICLE II

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporations Act other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Business Corporations Act.

ARTICLE III

The name of the initial registered agent for service of process is Ball Janik LLP, Jon Oden and the street address of the initial registered office of the Corporation is 201 Pine Street, Suite 825, Orlando, FL 32801.

ARTICLE IV

The initial street address of the Corporation is 513 S. Florida Avenue, Tampa, FL 33602.

ARTICLE V

The initial mailing address for the Corporation is 6705 Columbine Way, Plano, TX 75093.

ARTICLE VI

The Corporation is authorized to issue 1,000 shares of Common Stock.

ARTICLE VII

Any action required or permitted by the Florida Business Corporations Act to be taken at a shareholders meeting may be taken without a meeting if the action is taken, in accordance with the Florida Business Corporations Act, by shareholders having not less than the minimum number of votes that would be necessary to take such action at a meeting at which all shareholders entitled to vote on the action were present and voted.

ARTICLE VIII

The liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under Florida law.


ARTICLE IX

The Corporation may indemnify to the fullest extent not prohibited by law any person who is made, or threatened to be made, a party to an action, suit or proceeding, whether civil, criminal, administrative, investigative or other (including an action, suit or proceeding by or in the right of the Corporation), by reason of the fact that the person is or was a director, officer, employee or agent of the Corporation or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to any employee benefit plan of the Corporation, or serves or served at the request of the Corporation as a director, officer, employee or agent, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint venture, trust or other enterprise. This Article shall not be deemed exclusive of any other provisions for indemnification or advancement of expenses of directors, officers, employees, agents and fiduciaries included in any statute, bylaw, agreement, general or specific action of the board of directors, vote of shareholders or other document or arrangement.

ARTICLE X
