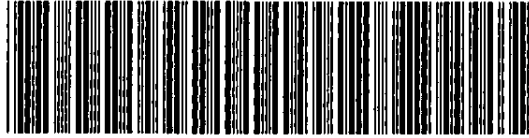

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following articles of incorporation.

ARTICLE I. CORPORATE NAME

The name of this corporation is SALES CUP, INC.

ARTICLE II. EXISTENCE

The corporation's existence shall begin on March 20, 2015.

ARTICLE III. PRINCIPAL OFFICE

ARTICLE IV. CAPITAL STOCK

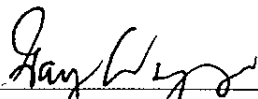
