**ARTICLE 1  
NAME AND ADDRESS**

The name of this corporation shall be SALON BRILLIANCE, INC. The initial principal business address of the corporation is 1387 Old Oak Lane, Naples, Florida 34110.

**ARTICLE 2  
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.


