ARTICLE OF INCORPORATION

OF

The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name and address of this corporation is:

NATURE OF BUSINESS:

(a) The general nature of the business of the corporation to be conducted by the corporation shall be to sell on-line merchandise.

(f) To guarantee, endorse, purchase, hold, sell. transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock, of or any bonds, security or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while the owner of such stock, to exercise all the rights, power, privileges of ownership, including the right to vote on such stock. (g) To purchase the corporate assets of any other corporation and engage in the same nature or character of business.
